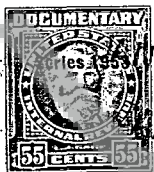

Beginning at a point which 801.1 feet south and 919.18 feet west of the northeast corner of Section 21, Township 2 North, Range 7 E.W.M., thence North $00^{\circ} 48'$ west 100 feet; thence north $79^{\circ} 51'$ west 254.64 feet to the initial point of the tract herein described; thence North $79^{\circ} 51'$ west 30 feet; thence north $00^{\circ} 48'$ west 60 feet; thence south $79^{\circ} 51'$ east 30 feet; thence south $00^{\circ} 48'$ east 60 feet to the initial point; said tract being designated as Lot 17 of Block Eleven of the unrecorded plat of the town of North Bonneville, Washington.
