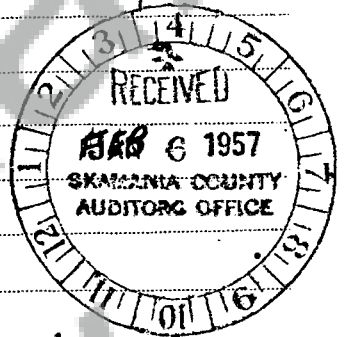

THIS INDENTURE, Made this 21st day of June, 1955,
