

RIGHT-OF-WAY AGREEMENT

THE GRANTOR Leon P. Montchalin and

Elyne Montchalin his wife, in consideration of

the sum of One and no/100 Dollars

(\$1.00), receipt of which is hereby acknowledged, conveyed and grants to the WEST COAST TELEPHONE COMPANY, a corporation, its successors or assigns, the GRANTEE, a perpetual right-of-way and easement over and across the following described property, situated in the COUNTY OF Skamania, STATE OF Washington, and particularly described as follows:

Commencing at a point on the southerly right of way line of State Road Number 8 and intersection of section line, said point being 161.2 feet south of the N.E. corner of Section 11, T.1N, E.5E W.M. Thence north-westerly along the southerly right of way line of State Road Number 8 to the easterly line of Prindle townsite. Thence S. 32° 30' east along said easterly line to a point which bears S. 52° 29' W. 30 feet from the N.E. corner of that tract of land deeded to E.W. Lee recorded on page 30, Book X of deeds, records of Skamania County, Washington. Thence N. 52° 29' E. along north line of said property 237.2' to N.E. corner of said tract. Thence S. 39° 03' E. 76.5 feet along easterly line of the said E.W. Lee property. Thence east 117.3 feet. Thence S. 37° 22' E. 166.6' to the northerly right of way line of Railroad Ave., a county road. Thence N. 77° 35' E. 163.9 feet along said right of way line to a 12" concrete culvert. Thence N. 12° 00' W. 200' more or less to the southerly right of way line of State Road Number 8. Thence E. 50° 14' W. along said right of way line to beginning.

The grantee shall have the right to erect and maintain poles with necessary crossarms, wires, cables, conduits, anchors and fixtures thereon and/or thereunder for telephone and other purposes, and shall have right to cut and remove shrubbery and foliage from said right of way so that the same shall not interfere with use of such lines.

Right of way hereby granted for telephone and other purposes, and shall have right to cut and remove shrubbery and foliage from said right of way so that the same shall not interfere with use of such lines.

Employees of said grantee shall, any time when necessary, have access to said right of way and the poles with necessary wires, crossarms, cables, conduits and fixtures thereon and/or thereunder for purposes of repairs, replacements, etc., provided always that said grantee shall be responsible for damage which may be done to the property above described by reason of such access. In the event that said poles, wires and anchors shall interfere with any future use of said tract by grantees, that grantors will move the same to a suitable location on said premises.
