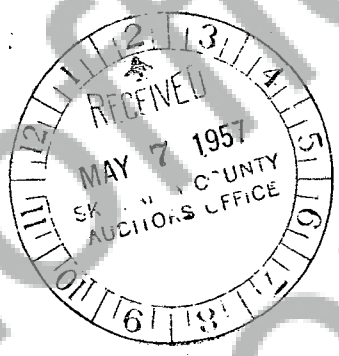

RELINQUISHMENT OF REAL ESTATE CONTRACT

IT IS AGREED between Carl N. Lahti and Agnes Lahti,
husband and wife
hereinafter called the first party, and Charles M. VonAhn and Alice M. VonAhn,
husband and wife
hereinafter called the second party, as follows:
That under date of October 15, 1956 the second party agreed to purchase from first party
the following described property in Skamania County, Washington, viz:
Commencing at a point on the west line of the Shepard D.L.C. 1321 feet
north of the intersection of the west line of said Shepard D.L.C. with
the south line of Section 36, Township 3 North, Range 7 E.W.M.; thence
south 43°30' west 173.8 feet; thence south 38°43' west 53.1 feet; thence
south 10°00' west 121.5 feet; thence south 20°52' east 109.3 feet; thence
south 34°24' west 61.9 feet; thence south 43°18' west 62.5 feet to the
center line of Kanaka Creek Cut Off Road; thence north 87°15' east
35 feet; thence south 50°45' east 115 feet more or less to the west
line of the Shepard D.L.C.; thence north along the west line of the
Shepard D.L.C. 521 feet more or less to the point of beginning.
EXCEPTING THEREFROM all legally established county roads.

which contract provided that time was the essence thereof and that if the purchaser failed to make the pay-
ments, or keep any of the covenants of the contract, the purchaser's rights should cease and determine and
all payments made should be regarded as liquidated damages;
That the second party has been unable to keep the terms of said contract and wishes to be absolved from
all liability thereunder, and the first party is willing to so absolve him on his admitting default and forfeiture
and relinquishing all rights under the contract and in the property;
NOW THEREFORE, in consideration of the mutual agreements herein, the first party does hereby
release the second party from all further liability under said contract and the second party admits that said
contract has been abandoned and all rights thereunder forfeited, and does hereby acknowledge that said
contract is at an end and that all rights thereunder have been forfeited.
