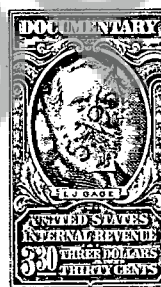
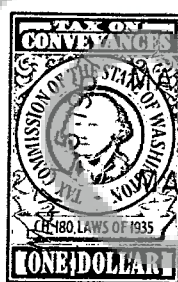
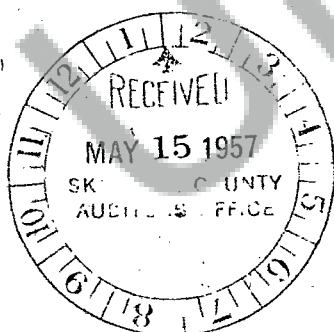
THE GRANTORS AUGUST REX, who acquired title as a single man, and LOUISE M. REX, his wife,
