remise, release and forever quitclaim unto the said part Y of the second part, and to his
heirs and assigns: Mining location 52144, starting from S. W. corner adjoining highway
property line, running North 1500 feet to N. W. corner; from N. W. corner 600 feet
to N. E. corner; from N. E. corner 1500 feet to S. E. corner on highway property
line; from S. E. corner running 600 feet joining highway property line to S. W.
corner; LOCATED in GIFFORD NATIONAL FOREST, Section 32, T 3 N, R 9 E, known as The
Ranger Mine, in Skamania County, Washington.


