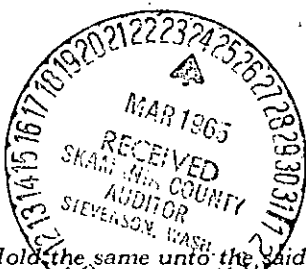

And the said part <sup>ies</sup> of the first part do hereby covenant to and with the said party of the second part, that the said part <sup>ies</sup> of the first part are lawful owner and holders of the said promissory note and Mortgage, and that they have good right to sell, transfer and assign the same as aforesaid, and that there is now due and owing upon the said promissory note and Mortgage the sum of Eight Hundred and Fifty and 93/100 (\$850.93) Dollars, with interest from the 25th day of February, 1963.

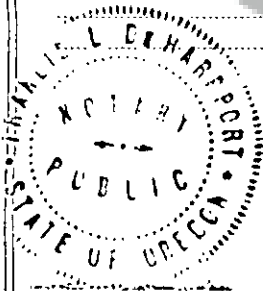
