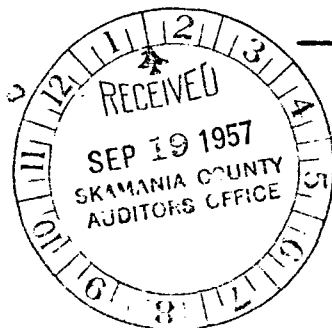
CERTIFICATE OF ABANDONMENT

THIS CERTIFICATE, made this 24th

for and on behalf of the United States.

WHEREAS, by instrument dated April 11, 1919, recorded in Book R of Deeds at Page 126 of the Deed Records of Skamania County and Volume 74, page 420 of the deed records of Cowlitz County, State of Washington, the Weyerhaeuser Timber Company granted to the Secretary of the United States Department of Agriculture for and in behalf of the United States of America, an easement and right of way over the following described real property situated in the County of Skamania, Twp. 7 N., Range 5 E., W.
