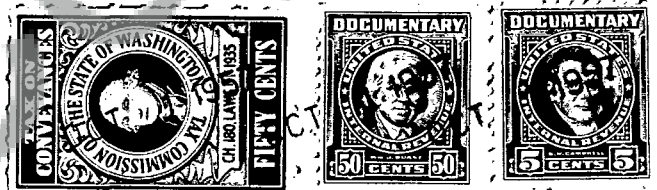

Beginning at a point 200 feet southerly of the intersection of the center line of Hollis Creek with the easterly line of the Wind River Road (also known as Government Springs Road) as surveyed and established; thence easterly at right angles to the course of the center line of said highway a distance of 400 feet; thence southerly and parallel to the center line of said highway a distance of 500 feet; thence westerly at right angles to the course of the center line of said highway a distance of 400 feet; thence northerly along the easterly line of said highway a distance of 500 feet to the point of beginning.

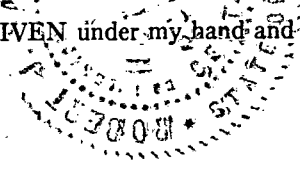
