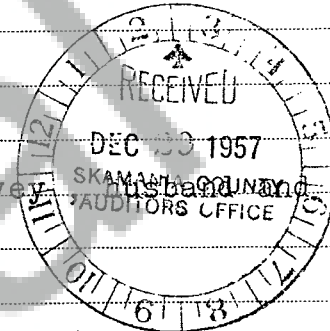
THIS INDENTURE, Made this 30th day of August, 19 57.
