

AFFIDAVIT OF GEORGE A. SWEENEY TO THE PUBLIC

I, GEORGE A. SWEENEY, being first duly sworn according to law, on oath depose and say:

That I, George A. Sweeney, am one of the children born to John Franklin Sweeney and Mary Elizabeth Sweeney, husband and wife, both of whom are now deceased, and make this affidavit in support of and to supplement my affidavit now on file in the Auditor's Office of Skamania County, Washington, Book 39, Page 477, filed for record June 22, 1955.

That seven (7) children were born as the issue of the marriage of John Franklin Sweeney and Mary Elizabeth Sweeney, to-wit: Mary Katherine, Charles Bryan, Ida B., Della, Emma, William F., and myself, George A.

That my father, John Franklin Sweeney, died January 13, 1931, at Stevenson, Washington, and, to the best of my knowledge, information and belief, I state that the gross value of the community estate owned by my father and my mother did not exceed a valuation of \$ 6,000.⁰⁰/_{XX} at the time of his death.

That my mother, Mary Elizabeth Sweeney, died July 29, 1941, at Stevenson, Washington, and, to the best of my knowledge, information and belief, I state that the gross value of my mother's estate did not exceed a valuation of \$ 4,000.⁰⁰/_{XX} at the time of her death.

That my brother, Charles Bryan Sweeney, a widower, died as the result of an automobile accident June 5, 1945 at Stevenson, Washington; that surviving him were his five (5) children, to-wit: Lorraine, Charlotte, Robert, John, and Ace L., all of whom are now living with the possible exception of Ace L. Sweeney, who left to go to the South Pacific in 1946 and has not been heard from or seen since; that, to the best of my knowledge, information and belief, I state that the gross value of the estate of my brother, Charles Bryan Sweeney, did not exceed a valuation of \$ 3,000.⁰⁰/_{XX} at the time of his death.

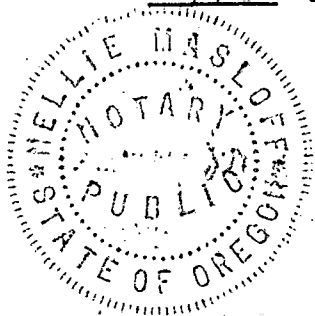
That my sister, Mary Katherine Sweeney Douglass, a widow, died October 9, 1951 in Vancouver, Washington, leaving no surviving children; that, to the best of my knowledge, information and belief, I state that the gross value of the estate of my sister, Mary Katherine Sweeney Douglass, did not exceed the valuation of \$ 500 ⁰⁰/_{xx} at the time of her death.

That none of the above estates have been subject to probate; that all of my remaining brothers and sisters are presently living.
