

E A S E M E N T

1 THE GRANTOR, GRACE LOCKE, a widow, in consideration of the love  
2 and affection for her son, the Grantee, GORDON C. LOCKE, hereby  
3 grants and conveys to the Grantee, his assigns and successors, a  
4 water right for the use and consumption of a normal domestic water  
5 supply for a one-family home and lawn and garden from a spring  
6 located on the following described property:

7 IN THE STATE OF WASHINGTON, COUNTY OF SKAMANIA:

8 The Northeast quarter of the Southwest quarter of Section  
9 8, Township 1 North, Range 5 EWM EXCEPTING one acre located  
10 in the Northeast corner thereof and described as follows:  
11 Beginning at the Northeast corner of the Northeast quarter  
12 of the said Section 8; thence South 208.71 feet; thence  
13 West 208.71 feet; thence North 208.71 feet; thence East  
14 208.71 feet to the point of beginning.

15 and an easement of ten (10) feet along the water line now running  
16 from said spring on Grantor's property as above described to the  
17 following described property owned by the Grantee:

18 IN THE STATE OF WASHINGTON, COUNTY OF SKAMANIA:

19 One (1) acre located in the Northeast corner of the following  
20 described property, to-wit:

21 The Northeast quarter (NE $\frac{1}{4}$ ) of the Southwest quarter (SW $\frac{1}{4}$ )  
22 of Section Eight (8) Township One (1) North of Range Five (5)  
23 East of the Willamette Meridian, further described as follows:  
24 Beginning at the Northeast corner of the above described  
25 property and extending 208.71 feet South, thence West 208.71  
26 feet; thence North 208.71 feet; thence East 208.71 feet,  
27 connecting with the starting line.

28 In exercising the rights herein granted, the Grantee and as-  
29 signs, may pass over said easement, repair the pipes and work on  
30 the said spring and do all work that is reasonably necessary for  
31 the enjoyment of the rights herein granted.
