

## WARRANTY DEED

THIS INDENTURE, dated this Aday of February

1958, by and between HARBOR PLYWOOD CORPORATION, a Delaware
corporation duly authorized to transact business in the State of
Washington (hereinafter sometimes called "Grantor"), and
INTERNATIONAL PAPER COMPANY, a New York corporation duly authorized
to transact business in the State of Washington (hereinafter sometimes called "Grantee").

## WITNESSETH, that:

The Grantor, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of all of which is hereby acknowledged, has granted, bargained and sold, and does hereby GRANT, BARGAIN and SELL and CONVEY unto the Grantez all the following-described real property situate, lying and being in the County of Skamania and State of Washington, to-wit:

The Southeast Quarter of the Northeast Quarter ( $SE_4^{\perp}$   $NE_4^{\perp}$ ) of Section Fourteen (14); the West Half of the Northwest Quarter ( $W_2^{\perp}$   $NW_4^{\perp}$ ), the Northeast Quarter of the Southwest Quarter ( $NE_4^{\perp}$   $SW_4^{\perp}$ ), the East Half of the Northeast Quarter ( $E_2^{\perp}$   $NE_4^{\perp}$ ), and Government Lots One (1) and Two (2) of Section Twenty-four (24); all in Township Seven (7) North, Range Six (6) East of the Willamette Meridian.

## SUBJECT TO:

- 1. An easement and right of way in gross granted to the United States of America by deed dated May 24, 1933, and recorded February 3, 1934, at page 442 of Book X of Deeds, Records of Skamania County, Washington, burdening Lot One (1) and Two (2) of Section Twenty-four (24), Township Seven (7) North, Range Six (6) East of the Willamette Meridian.
- 2. An easement for a telephone transmission line granted to the United States of America acting by and through the Forest Service, U.S.D.A., by deed dated November 6, 1951, and recorded February 5, 1952, at page 165 of Book 34 of Deeds, burdening the South Half (S2) of Section Twenty-four (24), Township Seven (7), North, Range Six (6) East of the Willamette Meridian, and other property described therein.





Together with all real property and interests in real property, including, but not by way of limitation of the foregoing, all lands, timber and rights to cut and remove timber, easements and rights-of-way, minerals and oil and gas in place and rights to explore for, extract and remove all minerals and oil and gas, water and water rights, and rights to remove earth, rock, sand and gravel at any time owned or held by the Grantor and not heretofore conveyed by it.

TO HAVE AND TO HOLD the said premises, with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all the improvements thereon, unto the said International Paper Company and unto its successors and assigns forever.

And the said Harbor Plywood Corporation, for itself and its successors, does hereby covenant to and with the Grantee, its successors and assigns, that the Grantor is the owner in fee simple of all said premises hereinabove described and has good and lawful right to sell and convey the same, that the said premises are free from all annumbrances other than the exceptions above stated, that the Grantor will execute any further necessary assurance of the title to the said premises subject to the foregoing exceptions and that, subject to the foregoing exceptions, the Grantor will forever warrant and defend the title to the said premises against the claims and demands of all persons whomsoever.
