REAL ESTATE CONTRACT

This CONTRACT FOR THE SALE OF LAND executed this date between JOSEPH ALBERT MEYERS and JOANN ARDELL MEYERS, husband and wife, hereinafter referred to as "Seller", and JETT T. FISK and ELIZABETH E. FISK, husband and wife, hereinafter referred to as "Purchaser",

WITNESSETH:

That for and in consideration of the covenants and agreements hereinafter provided, the Seller hereby agrees to sell and convey to the Purchaser, and
the Purchaser agrees to buy of the Seller the following described real property,
hereinafter referred to as the "premises" or the "property", upon the terms and
conditions provided in this contract.

DESCRIPTION OF PROPERTY: Situate in Skamania County, State of Washington:

That portion of the Southwest quarter of Section Six (6), Township One (1) North, Range 5 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point on the North line of the Cape Horn County Road which point is approximately 1854 feet, measured along the North line of said road, East of the West line of said Section 6, said point of beginning being the Southeast corner of the tract conveyed to Joseph Albert Meyers, et ux, by Deed recorded in Book 33 of Deeds, at page 496, records of said County; thence North 435 feet, more or less, to the Southeast corner of the tract conveyed to A. R. Meyers, et ux, by Deed recorded in Volume 40 of Deeds, page 87, records of said County; thence West 523 feet, more or less, to the Northeast corner of the tract conveyed to Claude Stelter, et ux, by instrument recorded in Book 36 of Deeds, at page 258, records of said County; thence South along the East line of said Stelter tract to the North line of said County Road; thence East along the North line of said County Road to the point of beginning.

AND AS CONDITIONS OF THIS CONTRACT THE PARTIES COVENANT AND AGREE AS FOLLOWS:

- 1. CONSIDERATION AND PAYMENT: The total purchase price is the sum of One thousand five hundred dollars (\$1,500.00) of which Purchaser has paid to Seller the sum of Twenty dollars (\$20.00) upon the execution of this contract, the receipt whereof Seller hereby acknowledges. The balance of the purchase price in the amount of \$1,480.00 shall be due and payable in monthly installments of Fifteen dollars (\$15.00), or more, at Purchaser's option. The unpaid balances of the purchase price from month to month shall bear interest at the rate of six (6%) percent per annum, and the aforesaid monthly installments shall be first applied in payment of said interest, and the balance of the same shall be applied to the principal. The monthly payments above provided shall commence on the same day of each month thereafter until the entire balance of the purchase price and interest is paid in full.
- 2. ASSIGNMENT: Purchaser covenants that he will not assign, transfer, sell, encumber or in any manner alienate his interest in this contract or the property covered thereby, either in whole or in part, without the written consent of the Seller.
- premises are paid through the year 1956, and the parties agree that the 1957 taxes thereon shall be prorated between the parties to the date of this sale. Purchaser further covenants to seasonably pay all such real property taxes and assessments of every kind and nature hereafter levied on said property.

- 4. INSPECTION AND RISK OF LOSS: Purchaser agrees that he has fully inspected the real property herein bargained to be sold and is relying on no representations or warranties except as expressed in this contract. Purchaser assumes the risk of loss or damage to said property by fire or otherwise, and agrees that the destruction of said property, in whole or in part, or that the taking of said property or any part thereof for public use, shall not constitute a failure of consideration on the part of the Seller.
- POSSESSION, USE AND TITLE: Purchaser shall be entitled to the exclusive possession of the premises upon the execution of this contract and thereafter during such times as this contract shall not be in default, except that Seller reserves the right to enter upon the premises at reasonable times to inspect and determine that the contract is being performed. Purchaser covenants to use the premises in a lawful manner, to commit no waste and to keep the premises in a clean and sanitary condition and in a good state of repair. Purchaser further covenants to cut no standing timber upon said property except with Seller's consent, Seller agreeing that said consent will not be unreasonably withheld so long as twothirds (2/3) of the gross price for said timber is applied on this contract; except that Purchaser shall be privileged to use said timber for domestic purposes on the property above described. Purchaser further covenants to seasonably pay all charges for repairs, improvements and utilities to the end that the same shall not become liens on the premises. In event Purchaser shall fail or neglect to make any such payments for taxes, repairs, utilities, or otherwise, as hereinbefore provided to be paid by Purchaser, then Seller may, at his election, make any such payments and the amount so paid shall be repayable by Purchaser on demand, or Seller may, at his option, add the amount thereof to the unpaid balance of this

Seller covenants upon the complete performance of this contract to deliver to Purchaser a Warranty Deed conveying the property as hereinbefore described to Purchaser, free and clear of all liens or encumbrances as of the date of this contract, but Seller shall not warrant against any liens or encumbrances created or suffered to be created by Purchaser subsequent to the date of this contract. Seller further covenants upon the performance of this contract to furnish to Purchaser a policy of title insurance in the amount of the purchase price insuring the title to said premises as herein bargained to be conveyed.

6. PERFORMANCE AND DEFAULT: Time and exact performance in all things shall be of the essence of this contract. In event of default by Purchaser in the payment of the several sums herein provided, or in event of the failure or neglect of the Purchaser to perform the several terms and conditions of this contract, and said default having continued for a period of 15 days, then Seller may declare Purchaser's interest hereunder forfeited and may repossess the premises and property, retaining any sums theretofore paid as liquidated damages for such failure to perform, and for the use and occupancy of the premises. Seller may, in the alternative bring action on any intermediate overdue installments or upon any payments made by Seller and repayable by Purchaser, and the institution of such action shall not constitute an election not to proceed otherwise as to any subsequent default. The waiver by Seller of any breach of this contract shall not be construed as a waiver of said covenants or of any future breach of any term of this contract.

In event Seller shall prevail in a legal or equitable action to enforce any rights under this contract, then Purchaser agrees to pay a reasonable sum as attorney's fees in said suit. It is agreed that any notice required by law concerning the enforcement or forfeiture of this contract may be made by registered United States mail, addressed to the mailing address of the premises, or to such other address as Purchaser may designate in writing.
