Upon the Petition of the guardian supported by letters of Edward Reed, attorney at law, of White Salmon, Washington, good cause, therefore, appearing to the Court,

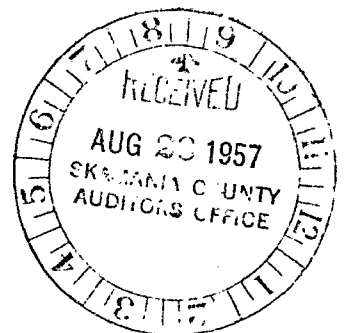
IT IS ORDERED that the guardian, Lena Gould, execute a Quitclaim Deed of any interest in the property described as
