WHEREAS, The field noties of the survey of Ignaz Wachter Subdivision of part of the W¹/₂ of NW¹/₂ of Section 36, Tp. 3 N. R. 7 E. W.M., as recorded at page 30 Plat Book "A", records of Skamania County, Washington are incomplete and uncertain.

NOW THEREFORE, in consideration of the mututal benefits to the parties hereto, it is agreed:

That the division line between Lots 1 and 2 of said Ignaz Wachter Subdivision is described with reference to the Survey line of the Bonne-ville Transmission line, as follows:

Commencing at a point on the West line of Section 36, Tp. 3 N. R. 7 E.W.M., which is N. 0° 16' 20" E. 486.86 feet from Station 300/45.74; thence S. 89° 6' 28" E. 137.13 feet to intersection with the northerly line of the 300 foot tract taken by the United States for said Transmission line; thence continuing on the same course 277.72 feet to intersection with the survey line of said Transmission line; thence continuing on the same course 114.35 feet to intersection with the southerly line of said 300 foot tract taken by the United States for Transmission line; thence continuing on the same course a distance of 196.99 feet to the Northeast corner of said Lot 1 and Southeast corner of said Lot 2.

(NOTE: Survey station 300/45.74 is located N. 0 ° 16 ° 20 " E. 526.28 feet from the quarter corner on the West line of said Section 36.)
