RIGHT OF WAY EASEMENT

For value received the undersigned Grantors, Una Z. Ward and Lyman W. Ward, wife and husband, hereby grant to Pacific Power & Light Company, a corporation, its successors and assigns, the Grantee, the right to use their existing road over their lands hereinafter described, for the sole purpose of access to and egress from the Grantee's right of way for its existing transmission and distribution line located upon, over and across the following described real property in Skamania County, State of Washington, to wit:

The Southwest quarter of the Southeast quarter ($SW_{4}^{\frac{1}{4}}$ of $SE_{4}^{\frac{1}{4}}$) and the Southeast quarter of the Southwest quarter ($SE_{4}^{\frac{1}{4}}$ of $SW_{4}^{\frac{1}{4}}$) of Section 27, Township 3 North, Range 9 East, Willamette Meridian;

an easement and right of way in and over which said real property for said existing transmission and distribution line was heretofore conveyed to Northwestern Electric Company (to which Company Pacific Power & Light Company is the successor in interest) by P.S.C. Wills, unmarried, by that certain deed dated April 18, 1912 and recorded June 4, 1912, in Book N, at Page 591, Record of Deeds of Skamania County, Washington.

The use of said road by Grantee, its successors or assigns, shall be subject to existing easements of record.

If said road is damaged by Grantee, its successors or assigns, the same shall be repaired, without cost to Grantor, within thirty days after completion of the job.


