

Continuing thence in a southwesterly and southeasterly direction across Sections 4, 3, 10, 15, 16, 21, 28 and 33, Township 18 South, Range 3 West, W.M. (on and along the right of way of Augusta Street and Laurel Hill Drive in the East Half of the East Half ( $E\frac{1}{2}E\frac{1}{2}$ ) of said Section 4, and crossing Bloomberg Road and 30th Avenue in the Southwest Quarter ( $SW\frac{1}{4}$ ) of said Section 10 and Dillard Road in the Southwest Quarter of the Southeast Quarter ( $SW\frac{1}{4}SE\frac{1}{4}$ ) of said Section 28), to a point on the south boundary of said Section 33, distant 1,950.0 feet, more or less, east of the southwest corner of said Section 33;

Continuing thence in a southwesterly and southeasterly direction across Sections 4, 9, 16, 21, 20, 29 and 32, Township 19 South, Range 3 West, W.M. (crossing County Road No. 294 and County Road No. 535 in the West Half ( $W\frac{1}{2}$ ) of said Section 16), to a point on the south boundary of said Section 32, distant 703.0 feet east of the southwest corner of said Section 32;

Continuing thence in a southwesterly and southeasterly direction across Sections 5, 6, 7, 18 and 19, Township 20 South, Range 3 West, W.M. (crossing County Road No. 1094 in the Northwest Quarter of the Northwest Quarter ( $NW\frac{1}{4}NW\frac{1}{4}$ ) of said Section 5), to a point on the west boundary of said Section 19, distant 1,375.0 feet, more or less, south of the northwest corner of said Section 19;

Continuing thence in a southwesterly and southeasterly direction across Sections 24, 25 and 36, Township 20 South, Range 4 West, W.M. (crossing County Road No. 858 in Lot 4 of said Section 24 and County Road No. 532 in the Southeast Quarter of the Northwest Quarter ( $SE\frac{1}{4}NW\frac{1}{4}$ ) of said Section 36), to a point on the south boundary of said Section 36, distant 329.7 feet east of the southwest sixteenth corner of said Section 36;

Continuing thence in a southwesterly and southeasterly direction across Sections 1, 12, 13 and 14 and a portion of Section 23, Township 21 South, Range 4 West, W.M. (crossing County Road No. 38 in the Northwest Quarter of the Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ) of said Section 1, Old U. S. Highway 99 and the S.P.R.R. in the South Half of the South Half ( $S\frac{1}{2}S\frac{1}{2}$ ) of said Section 12 and Interstate Highway 5 in the North Half of the North Half ( $N\frac{1}{2}N\frac{1}{2}$ ) of said Section 13), to a point on the County Line between Lane County, Oregon and Douglas County, Oregon, which point is on the mid-section line of said Section 23 and bears northerly, a distance of 2,100.0 feet, more or less, from the south quarter corner of said Section 23;
