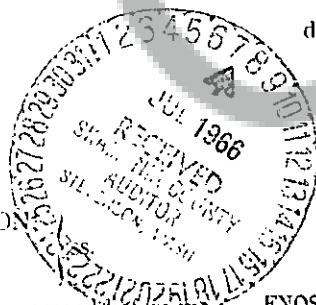
TOGETHER WITH right of way over and across existing alley for access to School Street;
