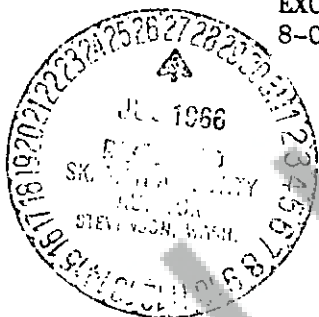
THE MORTGAGOR S **CLYDE L. KELLY and MARILYN P. KELLY, husband and wife,**

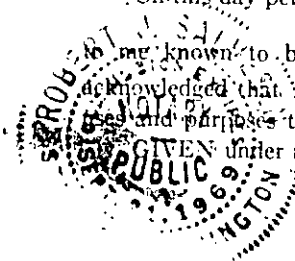
