## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this date by and between Gordon A. Hogan and Jean A. Hogan, husband and wife, both of Skamania County, State of Washington:

## WITNESSETH:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and

we hereby mutually agree that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate; and

IT IS FURTHER ACREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of Gordon A. Hogan while the said Jean A. Hogan survives, be vested in Jean A. Hogan absolutely and in fee simple as her sole and separate property; and in the event of the death of Jean A. Hogan while the said Gordon A. Hogan survivies, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of
