the owner and holder of that certain mortgage bearing date the 26th day of August, 1966, executed by Lillian G. Perry

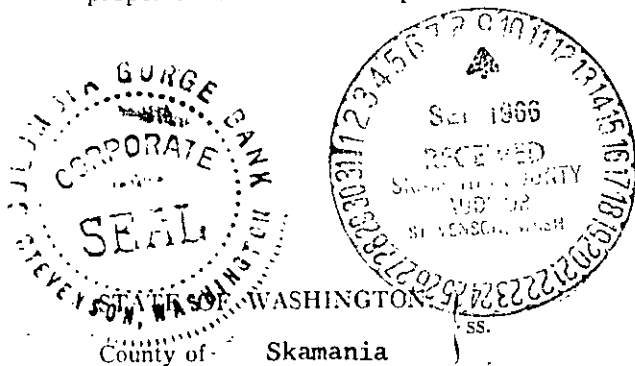
to secure payment of the sum of Nine Thousand One Hundred and No/100 - - - - - (\$9,100.00) - - - - - Dollars and interest,
