for and in consideration of Ten Dollars and other Valuable Considerations,

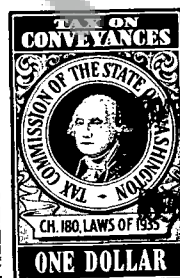
in hand paid, conveys and warrants to JOSEPH G. GODFREY, a single man,

the following described real estate, situated in the County of Skamania, State of Washington:

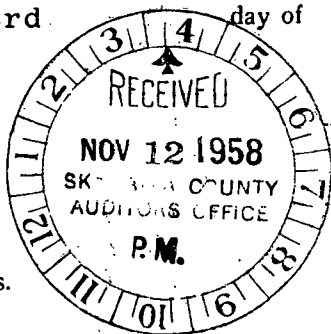
