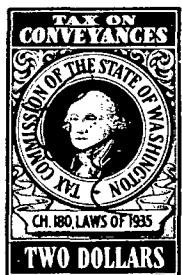


EXECUTRIX'S DEED

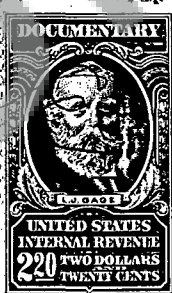
