

QUITCLAIM DEED

FOR A VALUABLE CONSIDERATION, ORA O. BURCH, FLORENCE E. CHAMPION and LOIS L. CALVERT, heirs and devisees of Theodore Lindis, deceased, and WILLIAM WILLIS, ESTHER T. NASH, LOUISE S. BRADFORD, ROBERT E. WILLIS, FLORENCE K. SENECA and E. EVELYN DRAIN, heirs of Mary M. Willis, an heir and devisee of the said Theodore Lindis, hereby quitclaim and convey to HARVEY J. WILLIS, as trustee, all of their right, title and interest in and to the following described real property situated in Skamania County, State of Washington, to-wit:

Beginning at a point 602 feet South and 260 feet North $89^{\circ} 06'$ West of where the West line of the Henry Sheperd D.L.C. intersects the Township line between Section 1, Township 2 North, and Section 36, Township 3 North, Range 7 East of Willamette Meridian, said point being on the South line of Second Street in the Town of Stevenson; thence South 110 feet to the true point of beginning; thence from said point of beginning West 50 feet; thence South to the Northerly line of State Highway No. 8 according to survey approved August 24, 1937; thence Northeasterly along the Northerly line of said State Highway No. 8 to a point due South of the point of beginning; thence North to the point of beginning.

Begin at a point 602' South of the point where the West line of the Shepard D.L.C. intersects the line between Sections 2 & 3, Township 3 North, Range 7; thence North 89° West along the South boundary of Second Street 320' to a pipe $1\frac{1}{4}"$ in diameter as set by LaBarre, this being the point of beginning; thence North 89° West 50'; South $0^{\circ} 54'$ West 150'; South 89° East 50'; North $0^{\circ} 54'$ East 150' to beginning.

Northeast corner of which is situated and lying 748' South and 310' West of the Northeast corner of Lot 9, Section 1, Township 2 North, Range 7; thence South 110'; West 50'; North 110'; East 50' to beginning; EXCEPTING therefrom 0.08 acres to State Highway.

Begin at a point on the South boundary line of Second Street, Stevenson, which is South 600' and North $89^{\circ} 14'$ West 463' from the intersection of the West line of the Shepard D.L.C. with the North line of Section 1, Township 2 North, Range 7; thence South 159'; South $89^{\circ} 14'$ East 103' to East line; North 159'; North $89^{\circ} 14'$ West 103' to beginning.
