## O R D E R

December 16, 1958

It appearing to the Commissioner of Public Lands at this time that Application No. 24675 has been filed in this office by Pacific Northwest Pipeline Corporation for an easement for right of way for a natural gas pipeline over the NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 16, Township 2 North, Range 7 East W.M. in Skamania County, as herein after more particularly described; and

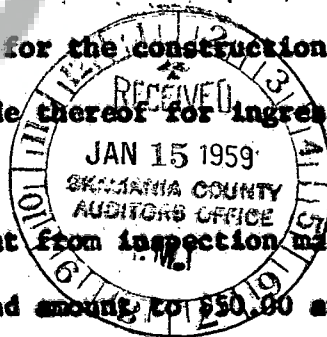
It further appearing that under and pursuant to Application No. 24257 that an easement for right of way for natural gas pipeline was granted to Pacific Northwest Pipeline Corporation over said NE $\frac{1}{4}$  of NW $\frac{1}{4}$  by Commissioner's Order of May 9, 1956 and that the charge thereunder was \$150.00; and

It further appearing that under Application No. 24675 the applicant submitted new plats showing the right of way over which the pipeline was actually constructed and laid and that said plats showed a considerable realignment and relocation of the right of way; and

It further appearing that said plats satisfactorily meet the requirements of the statutes in the matter of the filing of a map showing the location of the pipeline; that the area included in said right of way as applied for, is limited to an amount necessary for the construction of said pipeline, together with sufficient land on either side thereof for ingress and egress to maintain and repair the same; and

It further appearing that from inspection made and other data secured that additional damages to the land amounting to \$50.00 and the Commissioner being fully advised, it is therefore

ORDERED and DETERMINED that Commissioner's Order of May 9, 1956 granting on easement for right of way for natural gas pipeline over the NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 16, Township 2 North, Range 7 East W.M., in Skamania County under Application No. 24257 be and the same is hereby cancelled; and it is further

ORDERED and DETERMINED that damages to the land in addition to the \$150.00 previously paid under Application No. 24257 be and the same are hereby appraised at \$50.00; that said amount together with the statutory fee has been deposited in this office by the applicant; and that an easement for right of way for a natural gas pipeline be and the same is hereby granted to Pacific Northwest Pipeline Corporation over and across and to include the following described land:

That portion of the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 16, Township 2 North, Range 7 East, W.M., included within the limits of a strip of land 75 feet in width and having 55 feet of such width on the northwesterly side and 20 feet of such width on the southeasterly side of the following described line:

Beginning at a point on the north line of said section 16, which is S 88° 59' E 2900.00 feet from the northwest corner thereof, and running thence S 38° 31' W 448.00 feet, S 52° 33' W 461.00 feet, S 34° 33' W 40.00 feet, S 20° 03' W 120.00 feet, S 11° 21' W 141.00 feet, S 24° 43' W 41.00 feet and S 38° 31' W 2477.00 feet, and thence S 46° 31' W 860.00 feet to a point on the west line of said section 16, which is S 0° 18' W 3526.00 feet from the northwest corner thereof, containing an area of 2.15 acres as shown on the plat thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington.

PROVIDED, however, that the State reserves unto itself, its successors or assigns, the right to cross this right of way at any and all times in connection with the use of adjoining property.
