## STATUTORY EXCHANGE DEED

RECITALS:

PATRICK LUMBER COMPANY, an Oregon corporation, whose address is Terminal Sales Building, Portland, Oregon, hereinafter called the GRANTEE, has, by deed of even date, deeded to WEYERHAEUSER TIMBER COMPANY, a Washington corporation, whose address is P. O. Box 1645, Tacoma 1, Washington, hereinafter called the GRANTOR, certain lands situated in Cowlitz County, Washington, which lands are to be equal in value to the real property described below.

NOW, THEREFORE, GRANTOR, for and in consideration of and in exchange for the conveyance by Grantee as aforesaid, conveys and warrants to Grantee all the merchantable timber only, including dead and down timber, meeting, as of and on November 15, 1958, the following specifications of merchantability, to wit:

(Affects that part of the premises lying in the  $SW_{4}^{1}$  of  $NE_{4}^{1}$  and lying in the  $NW_{4}^{1}$  of  $SE_{4}^{1}$ ).
- 2. An easement and right of way to improve, maintain, and use a road, granted by Weyerhaeuser Timber Company, a Washington corporation, to Harbor Plywood Corporation, a Delaware corporation, under a certain contract between said parties, dated September 30, 1953 and recorded December 3, 1953 in Volume 37 of Deeds, Records of Skamania County, Washington, all of Grantee's therein right, title, and interest in said contract relating to said easement and right of way having been

assigned by said Grantee therein to International Paper Company, a New York corporation, by Assignment dated February 14, 1958. (Affects that portion of the premises above described lying in the  $SW^{\frac{1}{4}}$  of  $NE^{\frac{1}{4}}$ , in the  $SE^{\frac{1}{4}}$  of  $NW^{\frac{1}{4}}$ , and in the  $NW^{\frac{1}{4}}$  of  $SE^{\frac{1}{4}}$ ).
