for and in consideration of Ten Dollars and other Valuable Considerations,

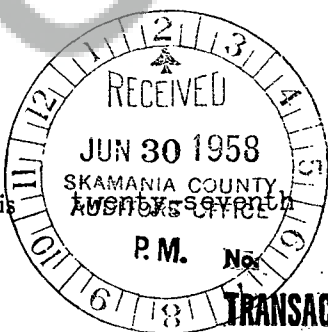
in hand paid, conveys and warrants to GLENN K. FRIZZELL and PATRICIA A. FRIZZELL,

That portion of the West Half of the Southeast Quarter of the North-west Quarter ($W\frac{1}{2} SE\frac{1}{4} NW\frac{1}{4}$) of Section 36, Township 3 North, Range 7 E. W. M., described as follows:

Beginning at a point on the northerly line of the county road known and designated as Gropper Road, said point being 320 feet easterly of the center line running north and south through the center of the $NW\frac{1}{4}$ of the said Section 36; thence north 208 feet; thence east 208 feet; thence south 208 feet, more or less, to the northerly line of the said Gropper Road; thence north 113 feet to the initial point of the tract hereby described; thence north 73 feet; thence north 74° east 102 feet, more or less, to the westerly line of the county road known and designated as Maple Way; thence south following the westerly line of said Maple Way 98 feet to a point north 85° east of the initial point; thence south 85° west 102 feet, more or less, to the initial point.
