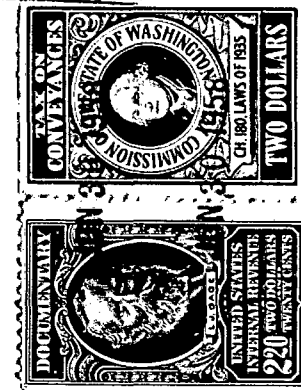

the following described real estate, situated in the County of Skamania, State of Washington:

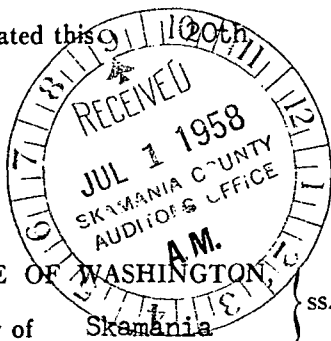

M., thence north on section line 214.5 feet; thence west 165 feet, more or less, to the center line of that certain highway formerly known as State Highway No. 8; thence following the center line of said highway in a southwesterly direction 280 feet, more or less, to a point on the north line of Lot 13, said Section 36; thence east 348.8 feet, more or less, to the point of beginning.
