(As the purpose of the deed is to adjust holding only no U.S. or State stamp, or excise tax required.)

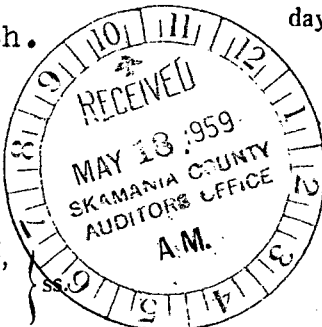
