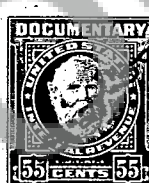
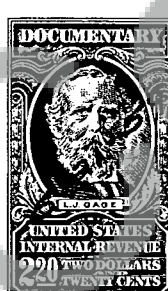
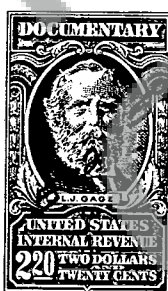
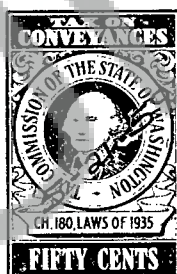
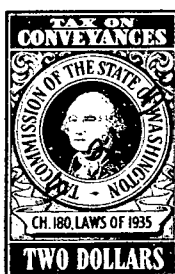
Statutory Warranty Deed

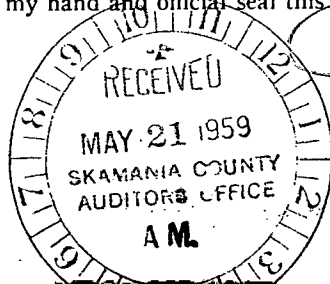
