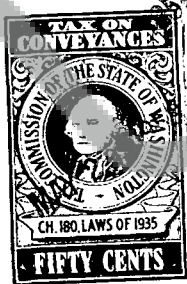
for and in consideration of Ten Dollars and other Valuable Considerations,

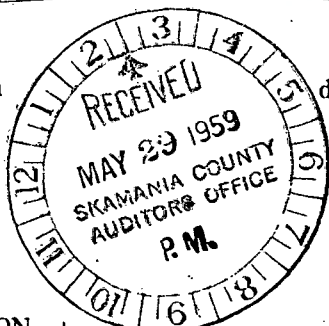
