CONTRACT OF SALE

This CONTRACT OF SALE made and entered into this 4th day of June, 1959, by and between Robert K. Garwood and Mary Lou Garwood, husband and wife, of Stevenson, Washington, hereinafter called the Seller, and William A. Berry, of North Bonneville, Washington, hereinafter called the Purchaser;

WITNESSETH:

The Seller agrees to sell to the Purchaser, and the Purchaser agrees to buy from the Seller, the following described property now situated at North Bonneville in Skamania County, Washington.

That certain dwelling house consisting of five rooms together with all the fixtures and plumbing installations now existing and constructed upon Lots 3A and 4A in Block four of the unrecorded plat of Brown's Court, which said Real Property is under lease to the Seller;

for the purchase price of Three Thousand, Seven Hundred and Fifty Dollars (3,750.00) of which Two Hundred and Fifty Dollars (250.00) has been paid, the receipt whereof is hereby acknowledged, and the Purchaser agrees to pay the balance of the purchase price in monthly installments of \$50 or more commencing on the 5th day of August, 1959, and on the 5th day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installmentsinclude interest at the rate of 6% per annum, and they shall be applied first to the interest and then to the Principal. The Purchaser reserves the right at any time while he is not in default under the terms and conditions of this contract to pay any part or all of the unpaid balance of the purchase price plus interest then due.

The Seller, for as long as the Purchaser shall be in good standing under the terms and conditions of this contract, hereby transfers and assigns to the Purchaser His possessory rights under the aforesaid lease dated and rent and subject to the obligations thereunder to pay ground rent and water rentals, which said obligations the Purchaser by the acceptance of this contract assumes and agrees to pay. The Purchaser agrees to keep the said dwelling house insured against loss by fire to the full insurable value thereofand to deliver to the Seller policies of fire insurance insuring the Seller, as owner, and the Purchaser as contract purchaser.

Upon full performance of this contract and all of the Purchaser's agreements hereunder the Seller agrees to deliver to the Purchaser a bill of sale to the above described awelling house and an assignment of the aforesaid lease.
