EASEMENT

The Grantors, WALTER H. ARP and DAISY ARP, husband and wife, of Skamania County, State of Washington, for and in consideration of One Dollar in hand paid hereby grant, bargain, sell, and convey to L. H. PIERCE and LENA L. PIERCE, husband and wife, doing business as L. H. PIERCE AUTO SERVICE, a partnership, an easement and a right of way for an eight inch water pipeline and an easement to construct, install and maintain on Hardy Creek an intake reservoir and dam not more than 30 inches in height above the natural bed of said creek together with the right of ingress and egress for the purpose of installing, repairing and maintaining said water pipeline, intake reservoir, and dam, the point of diversion from Hardy Creek being location 218 feet, more or less, in a northwesterly direction from the intersection of said Hardy Creek with the center of Primary State Highway No. 8; said pipeline to be located by the Grantees within the channel of Hardy Creek leading from the point of diversion as aforesaid to the northerly right of way of Primary State Highway No. 8; and said water pipeline, dam and intake reservoir to be constructed by the Grantees without cost to the Grantors on the following described real property located in Skamania County, State of Washington, to-wit:

C., said point also being the southeast corner of said Government Lot 13; thence north to the northeast corner of said Government Lot 13; thence along the north line of said Government Lot 13 west 660 feet; thence south to the south line of said Government Lot 13; thence along the south line of said Government Lot 13 north 89° 56' east to a point 554 feet distant from the point of beginning; thence south 42° 43' east to a point on the northerly right of way line of Primary State Highway No. 8; thence following the northerly right of way line of said highway northeasterly to intersection with the east line of the said Snooks D.
