Commencing at a point on the south line of Stevenson Park Addition
and 938.2 feet east of the west line thereof, said point being on the
center line of Kanaka Creek Road, thence S 24°12' East along the center
line of road 196.8 feet, thence following a 10°00' curve to the left with
a central angle of 26°28' and a length of 264.67 feet to Station P.T.
34+25.57, thence S 50°40' East 110 feet more or less to the westerly
right of way line of the road known as Strawberry Road, sometimes called
the Loop Road, thence 25 feet northeasterly as measured at right angles
to the center line, thence N 50°40' West 110 feet more or less to a
point which is 25 feet northeasterly from Station P.T. 34+25.57, thence
southwesterly 5 feet, thence following the 10°00' curve mentioned above
in northwesterly direction at 20 feet from center line to a point north-
easterly from true point of beginning, thence southwesterly to begin-
ing. Description includes a portion of existing right of way. Right




