in hand paid, conveys and warrants to Lee R. Craig, a widower

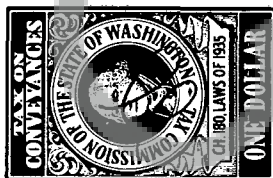
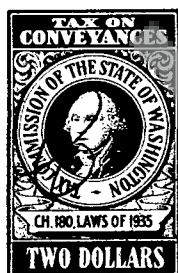

of beginning.

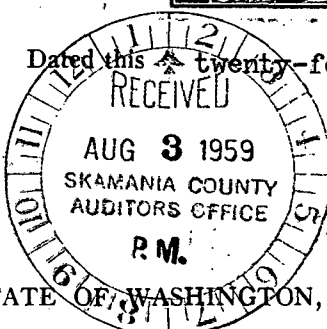
