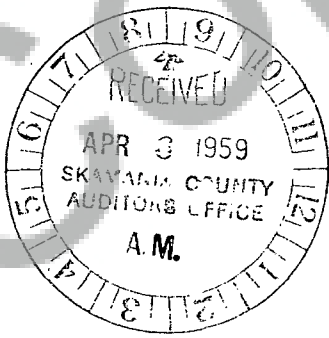
have bargained and sold, and by these presents do grant, bargain, sell and convey unto said
