## AFFIDAVIT

I, MARIE WENTZEL, being first duly sworn, upon oath depose and say: That I am the widow of FRED ADAM WENTZEL, also known as FRED WENTZEL. That said Fred Wentzel died July 21, 1953 in the City of Oregon City, County of Clackamas, State of Oregon, and was at the time of his death a resident of Gladstone, Clackamas County, Oregon.

That the decedent and I were duly and regularly married on the 20th day of March, 1912 at Park Rapids, Hubbard County, Minnesota.

That during our marriage Fred Wentzel and myself acquired title to the following-described real property as husband and wife:

Commencing at a point 1800 feet South of the one-quarter corner between Sections 30 and 31, T. 3 N., R. 8 E., W. M., thence N. 55° 30° East 1007 feet to the northeast corner of that tract of land conveyed to C. M. Youmans by deed recorded at page 11, Book "R" of Deeds, records of Skamania County, Washington, which is the initial point of the tract hereby described; thence South to the Columbia River; thence following the Columbia River upstream to a point 200 feet East of Smith Creek; thence northerly following a line which is parallel to and 200 feet distant from the center line of said Smith Creek (measured in an easterly direction at right angle) to intersection with the southerly line of State Highway No. 8; thence following the said Highway in a westerly and southerly direction to a point on the easterly boundary thereof, which is S. 55° 30' west of the place of beginning; thence N. 55° 30' E. to the initial point; SAVE AND EXCEPT all mineral and mineral deposits therein and thereon; and EXCEPT those tracts of land conveyed to Spokane, Portland & Seattle Railway Company for rights of way by deed dated January 24, 1906, recorded in Book "I" of Deeds at page 425 on January 27, 1906, and by deed dated June 8, 1906 and recorded Book "K" of Deeds at page 14 on June 9, 1906; RESERVING, HOWEVER, unto the grantors all minerals of all and any kind that may be on or under the aforesaid land; and ALSO EXCEPTING the following: The rights of Columbia Gold and Copper Mining Company listed in deed recorded in Book "L", page 428, Deed records of said County and State; and ALSO EXCEPTING county roads, rights-of-way and easements of record; ALL SITUATE IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON.

That said Fred Wentzel and I were husband and wife at the time of the death of Fred Wentzel; that a certified copy of the death certificate of said Fred Wentzel, aka Fred Adam Wentzel, is attached hereto and made a part of this affidavit.
