STATUTORY WARRANTY DEED

Commencing at a point 1735 feet East and 760 feet South of the quarter section corner on the West line of Section 6, Township 1 North, Range 6 East of the Willamette Meridian said point being at the intersection of the South line of the right of way of the North Bank Highway and the North line of the Carlson tract of land, marked by a stake 2x2x16 inches with tack on top; thence North 34 degrees East 220 feet; thence North 29 degrees East 208 feet, thence North 18 degrees East 200 feet, thence South 78 degrees 48 minutes East 240 feet, thence North 68 degrees 48 minutes East 240 feet, thence North 68 degrees 48 minutes East 375 feet; thence North 60 degrees 16 minutes East 168 feet; thence South 23 degrees 54 minutes East 121 feet, to the Northeast corner of the Carlson tract; thence following the North line of the said Carlson tract; thence following the North line of the said Carlson tract in a Westerly direction approximately 1246 feet to the place of beginning and containing 3½ acres more or less, all of said property being North of the North Bank Highway as now located, and making the dividing line between the properties owned by the grantors and grantees the center of the present North Bank Highway.
