Grantee is hereby granted the full use of all access and existing logging roads to and across the property herein described for the purpose of removing the timber, together with the right to construct and maintain such roads on the property of Grantor as may be necessary for the logging and removal of the above described timber. Grantor hereby guarantees unto Grantee access to the above described lands from public roads and covenants that it will take whatever measures are necessary to provide access.

In cutting or removing said timber, Grantee agrees to comply with all Federal, State and local laws and regulations and save and protect Grantor, its successors and assigns, harmless from any liability or damage what soever in connection with or resulting from Grantee's operations.
