THIS EASEMENT, made the 1st day of October, A.D. 1959, by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation of the State of Wisconsin, grantor, to the COUNTY OF SKAMANIA, STATE OF WASHINGTON, a municipal corporation, grantee, WITNESSETH:

The grantor, in consideration of the sum of ten thousand two hundred fifty dollars (\$10,250) unto it paid, the receipt whereof is acknowledged, grants unto the grantee, its successors and assigns, the right to use and occupy for a public highway the following described parcels of land in Skamenia County, Washington, to-wit:

# Parcel No. 1

A parcel of land lying in the northwest quarter (NW) of Section thirty-five (35), in Township nine (9) North, Range five (5) East of the Willamette Meridian, the said parcel being described as follows:

Beginning at a point at the northwest corner of Section 35, said point being the common corner to Sections 26, 27, 34 and 35; thence S. 00° 14' E. along the westerly line of said Section 35-9N-5E., W.M., 500.00 feet; thence N. 89° 46' E. 500.00 feet; thence N. 00° 14' W. 500.00 feet to the north line of said Section 35-9N-5E, W.M.; thence west along said north line 500.00 feet, more or less, to the point of beginning

TO HAVE AND TO HOLD, the said parcels of land unto the grantee, and its successors and assigns, so long as the same shall be used for public highway purposes, and whenever said parcels shall cease to be used for public highway purposes the estate hereby granted shall revert to and become vested absolutely in the grantor, its successors and assigns.
