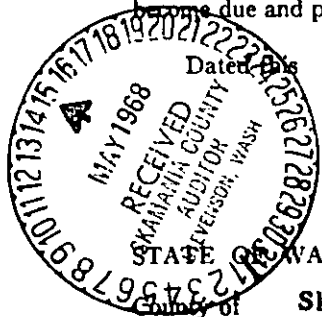
THE MORTGAGORS DONALD W. WHITE and SHARON Y. WHITE, husband and wife,
