## II.

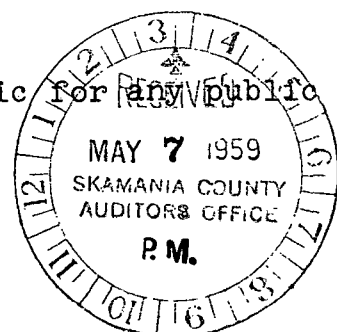
