\*(Executed Counterpart No. 120 was filed as a Financing Statement in the office of the Secretary of State of the State of Oregon on February 9, 1968 and assigned Uniform Commercial Code No. B22276. Chapter 395, Oregon Laws 1967, exempts mortgages and deeds of trust of utilities from general filing requirements of the Uniform Commercial Code and provides for a single filing thereof with the Secretary of State.

Executed Counterpart No. 122 was filed on February 21, 1968 with the Auditor of the City of Portland in compliance with the requirements of the Charter of the City of Portland, applicable to instruments mortgaging franchises for the use of city streets and highways by public utilities.)
