

KNOW ALL MEN BY THESE PRESENTS, That COLUMBIA GORGE BANK, successor in interest to the Bank of Stevenson, the owner and holder of that certain mortgage bearing date the 1st day of June, 1964, executed by Charles L. Sweiberg and Sharon A. Sweiberg, husband and wife, to secure payment of the sum of Nine Thousand and no/100ths - (\$9,000.00) - Dollars and interest, and recorded in the office of the County Auditor of Skamania County, State of Washington, on the 3rd day of June, 1964, in Volume 42 of Mortgages, at page 09, being Auditor's File No. 63348, for value received, does hereby release and discharge from the lien of the said mortgage the following described portion of the mortgaged premises, situate in the County of Skamania, State of Washington, to-wit:

Tracts of land located in the Southeast Quarter of the Northeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 26, Township 4 North, Range 7 E. W. M. described as follows:

Beginning at a point 765 feet east of the southwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the said Section 26; thence north 190 feet; thence south 77° 09' east 120 feet; thence south to intersection with the south line of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the said Section 26; thence west along said south line to the point of beginning; and

Beginning at a point 765 feet east and 205 feet north of the southwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of the said Section 26; thence south 88° 00' west 120 feet; thence north 200 feet, more or less, to the center of Trout Creek; thence in an easterly direction following the center of Trout Creek to a point north of the point of beginning; thence south 174 feet, more or less, to the point of beginning.

But this release shall not impair the lien of the said mortgage as to the lands therein described not hereby released.
