KNOW ALL MEN BY THESE PRESENTS, That COLUMBIA GORGE BANK, a corporation,

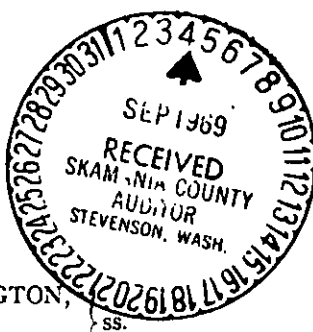
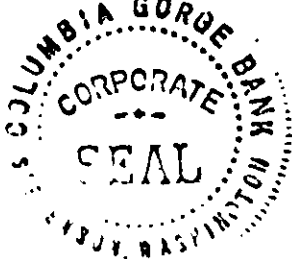

A tract of land located in the Northwest Quarter of the Southeast Quarter (NW¼ SE¼) of Section 17, Township 3 North, Range 8 E. W. M., described as follows:

Beginning at the center of said Section 17; thence south 89° 55' east 30 feet; thence south 380 feet; thence south 89° 55' east 208 feet to the initial point of the tract hereby described; thence south 208 feet; thence south 89° 55' east 418 feet, more or less, to the westerly line of the 150 foot right of way granted to the State of Washington for State Secondary Highway No. 8-C by deed dated October 20, 1956, and recorded at page 499 of Book 42 of Deeds, Records of Skamania County, Washington; thence in a northerly direction following said westerly line to a point south 89° 55' east from the initial point; thence north 89° 55' west 310 feet, more or less, to the initial point; said tract containing 1.75 acres, more or less.

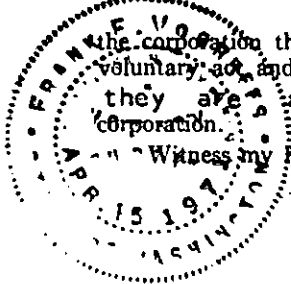
