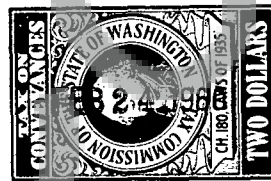
THE GRANTOR S GLENN B. KELLER and VERA L. KELLER, husband and wife,

in hand paid, conveys and warrants to R. M. HEGEWALD and HELEN B. HEGEWALD,
husband and wife,

the following described real estate, situated in the County of Skamania, State of Washington:

Beginning at the southwest corner of Lot 8 in Section 1, Township 2 North, Range 7 E. W. M.; thence south along the section line between Sections 1 and 2, said township and range, 334.67 feet and thence south 77° 25' west 691.56 feet to the initial point of the tract hereby described; thence south 46° 00' west 424.5 feet to intersection with the division line between the northeasterly and southwesterly halves of the Baughman D. L. C.; thence north 64° 10' west 413 feet, more or less, along the said division line to intersection with the westerly line of the said D. L. C.; thence north 00° 01' west along said division line 526.94 feet to the northerly bank of Foster Creek; thence in an easterly direction along the northerly bank of Foster Creek to a point north 29° 31' west of the initial point; thence south 29° 31' east 523.7 feet to the initial point; EXCEPT that portion thereof lying northeasterly of the county road known and designated as the Foster Creek Road.

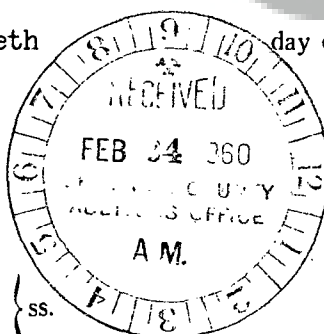
