for and in consideration of One Dollar, Love and Affection

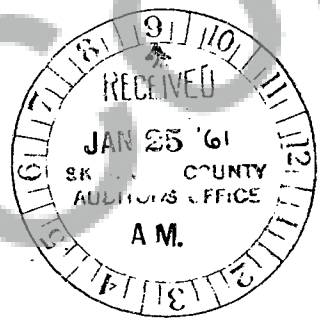
in hand paid, conveys and warrants to HENRY PEYROLLAZ and ALINE PEYROLLAZ, husband and wife,
