WARRANTY DEED

The Grantor, WEYERHAEUSER COMPANY, a corporation duly incorporated under the laws of the State of Washington, of Tacoma, Washington, for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, receipt of which is hereby acknowledged, conveys and warrants to PACIFIC POWER & LIGHT COMPANY, a Maine corporation, qualified to do business in the State of Washington, having its principal business office in Portland, Oregon, Grantee, the following described tractsof land situated in Skamania County, in the State of Washington, to-wit:

IN SECTION TWENTY-ONE (21), TOWNSHIP SEVEN (7) NORTH, RANGE FIVE (5) EAST OF W. M.

RESERVING to Grantor all minerals, including oil, gas, and other hydrocarbons underlying all of said lands except the N_2^1 of NW_4^1 , the SW_4^1 of NW_4^1 , the N_2^1 of SW_4^1 , the SW_4^1 of SW_4^1 , and the NW_4^1 of SE_4^1 of said Section 21, provided that such reserved mineral rights shall be exercised so as not to interfere with the reconstruction, operation, or maintenance of Swift Hydroelectric Project.

ALSO, RESERVING unto the Grantor for a term of 30 years from the date hereof, all timber, regardless of merchantability, on the uninundated portions of the hereinabove conveyed parts of following described lands:

The Southwest Quarter of Northeast Quarter (SW_{4}^{1} of NE_{4}^{1}), the Northwest Quarter of Southwest Quarter (NW_{4}^{1} of SW_{4}^{1}), the Northwest Quarter of Southeast Quarter (NW_{4}^{1} of SE_{4}^{1}), and the Southeast Quarter of Southeast Quarter (SE_{4}^{1} of SE_{4}^{1}) of Section Twenty-one (21), the Southwest Quarter of Southwest Quarter (SW_{4}^{1} of SW_{4}^{1}) of Section Twenty-three (23), the South Half of Northeast Quarter (S_{2}^{1} of NE_{4}^{1}) and Lots Six (6) and One (1) of Section Twenty-five (25), and the Northwest Quarter of Northwest Quarter (NW_{4}^{1} of NW_{4}^{1}), Lots Nine (9), Eight (8), and Seven (7), and the Southeast Quarter of Southeast Quarter (SE_{4}^{1} of SE_{4}^{1}) of Section Twenty-seven (27), Township Seven (7) North, Range Five (5) East of W. together with the right to enter upon said uninundated portions at any time, or times, during said term of 30 years and to cut, log, and remove the said timber in the usual and customary manner, with all rights, easements, and privileges in and upon said uninundated portions necessary therefore, provided that such reserved rights shall be exercised so as not to interfere with the reconstruction, operation, or maintenance of Swift Hydroelectric Project.
