WAIVER OF CLAIM FOR DAMAGES  
AND CONSENT TO LOCATE ROAD

International Paper Company, a New York corporation,  
 being the owner of the property herein described, does in considera-  
 tion of the benefits and advantages to accrue to it by the location  
 and establishment of the proposed County Road, hereby consents that  
 said road be established as described in the petition herein and  
 as examined and surveyed, and forever relinquishes to Skamania  
 County, Washington, a Right -of-Way variable feet in width over and  
 across the following described piece or parcel of land, to-wit:

A right of way 30 feet, being an additional 10 feet  
 in width on the westerly side of the Center line of  
 existing road from a point where the Westerly right  
 of way line intersects the Easterly line of the Wm.  
 Murphy D. L. C. to a point on the westerly Right  
 of way line which is 701.22 ft. South and 596.25 ft.  
 west from the N.E. corner of said Murphy D. L. C.  
 being the centerline at Station 0+00, thence a  
 variable width on westerly side of the new center-  
 line to the North line of Murphy D. L. C. The  
 above mentioned variable width being an additional  
 width which when added to existing Right of way  
 will be 30 feet in width as measured at right  
 angles from the Centerline as shown on plat of  
 said road under date of October 11, 1960.

and waives all claims for damages of whatever kind which may be  
 occasioned to said land or any portion of the same by examining,  
 surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington,  
 the said Right-of-Way with full power and authority to examine,  
 survey, lay out and establish said Road as proposed, and to



peacefully maintain the same as a County Road.
